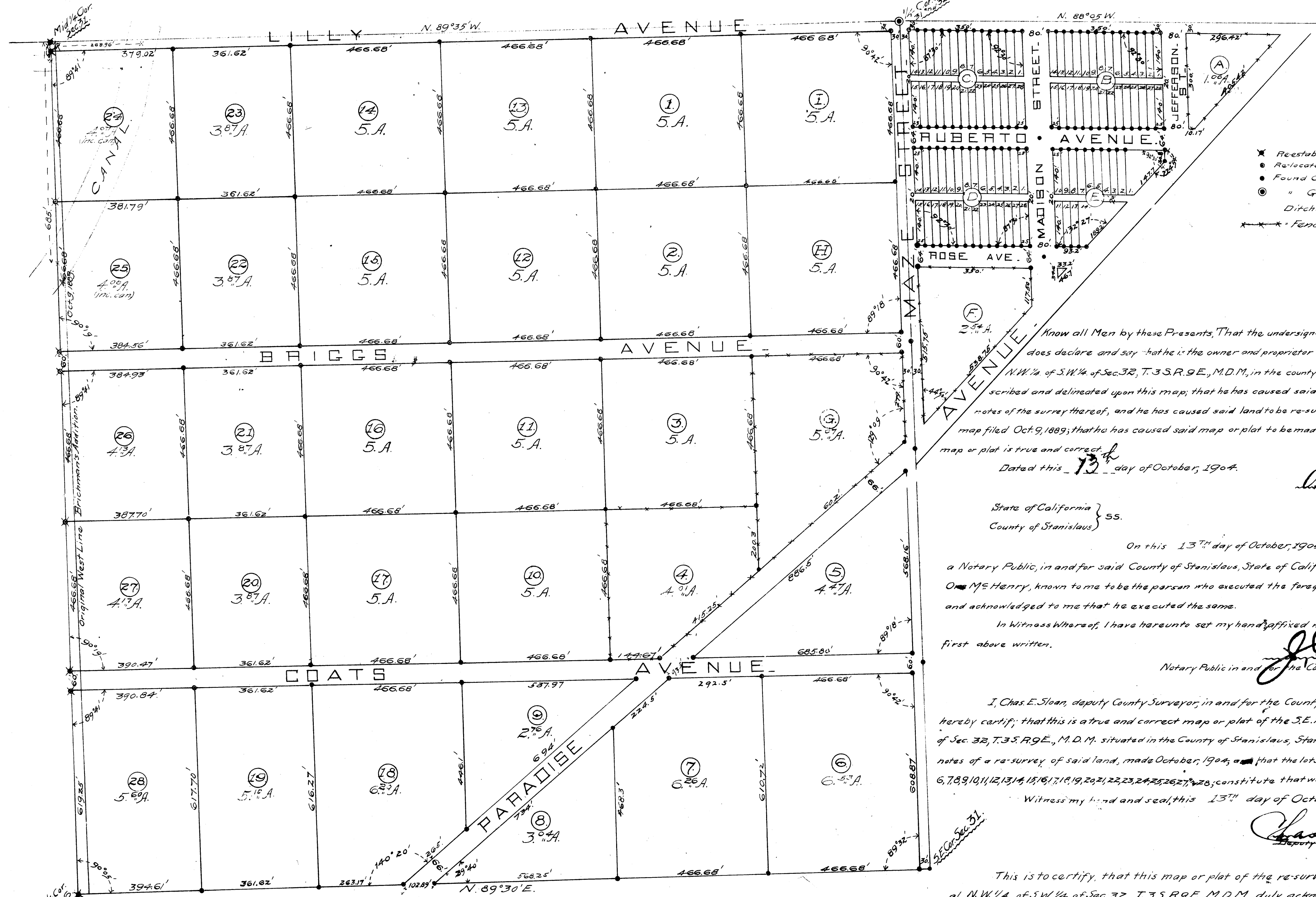


# RE-SURVEY OF BRICHMAN'S ADDITION TO THE CITY OF MODESTO
