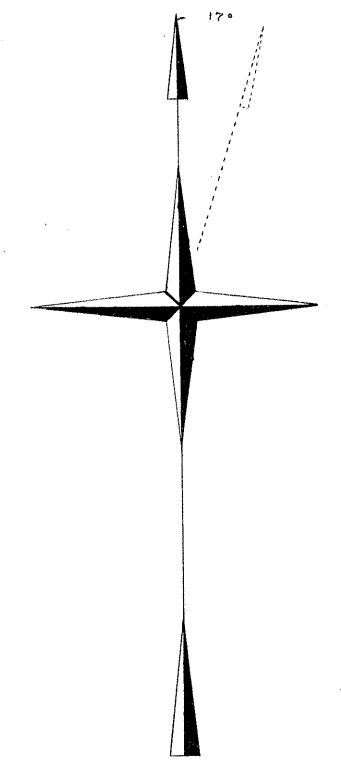


MAP
