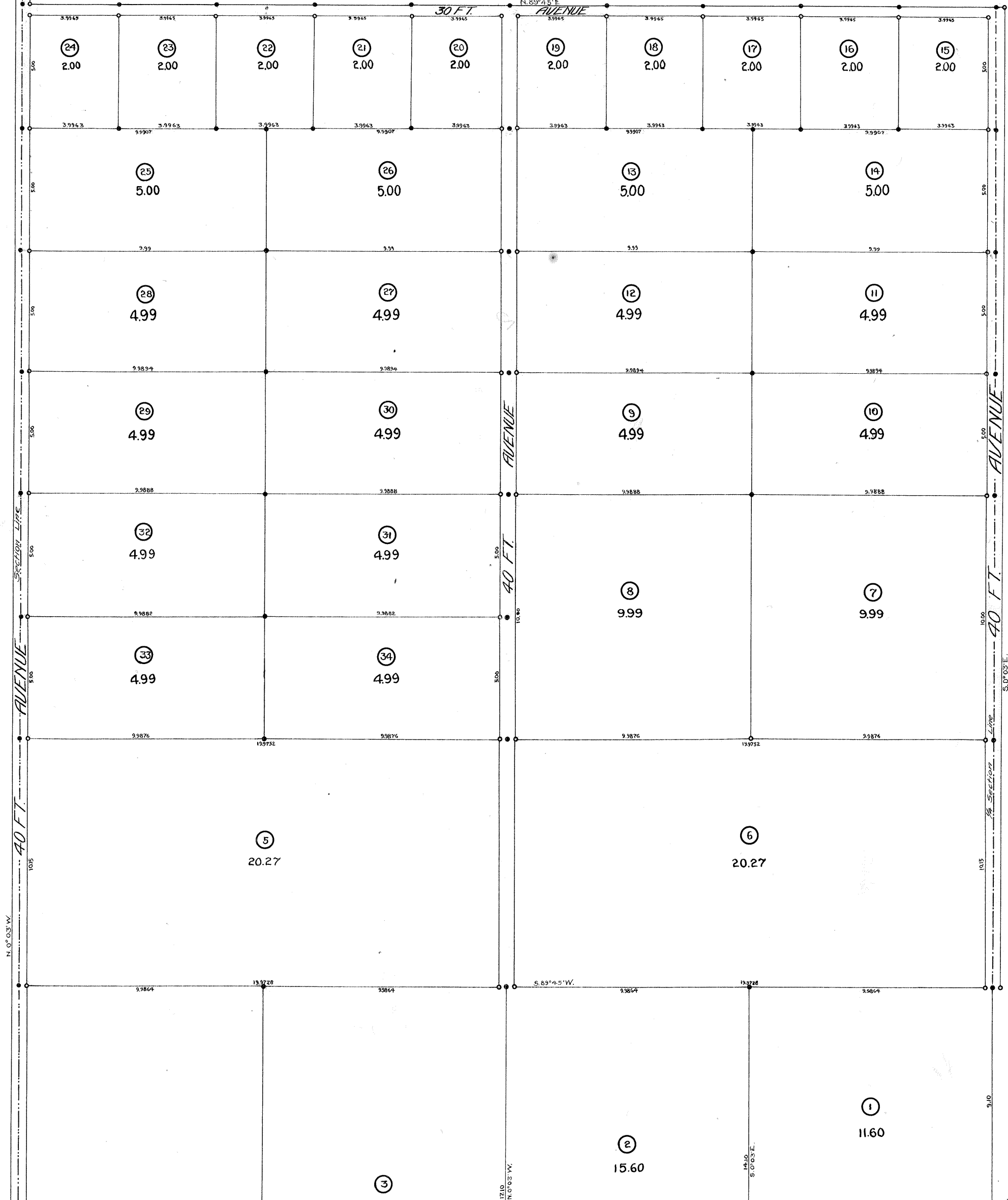

**ROUSE COLONY**

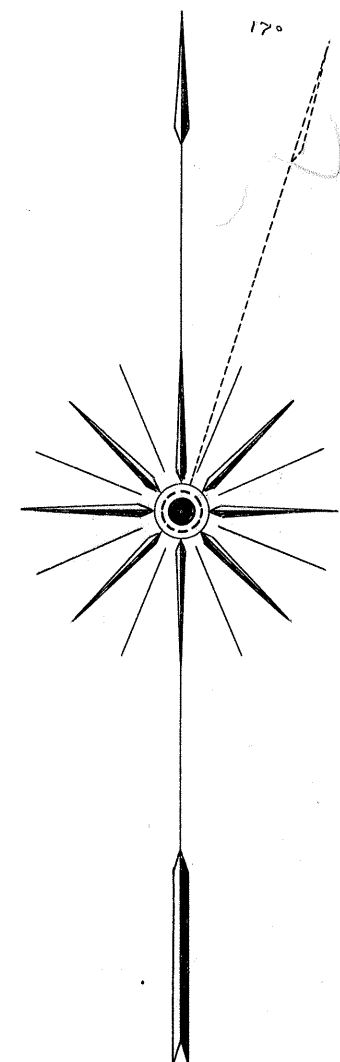
