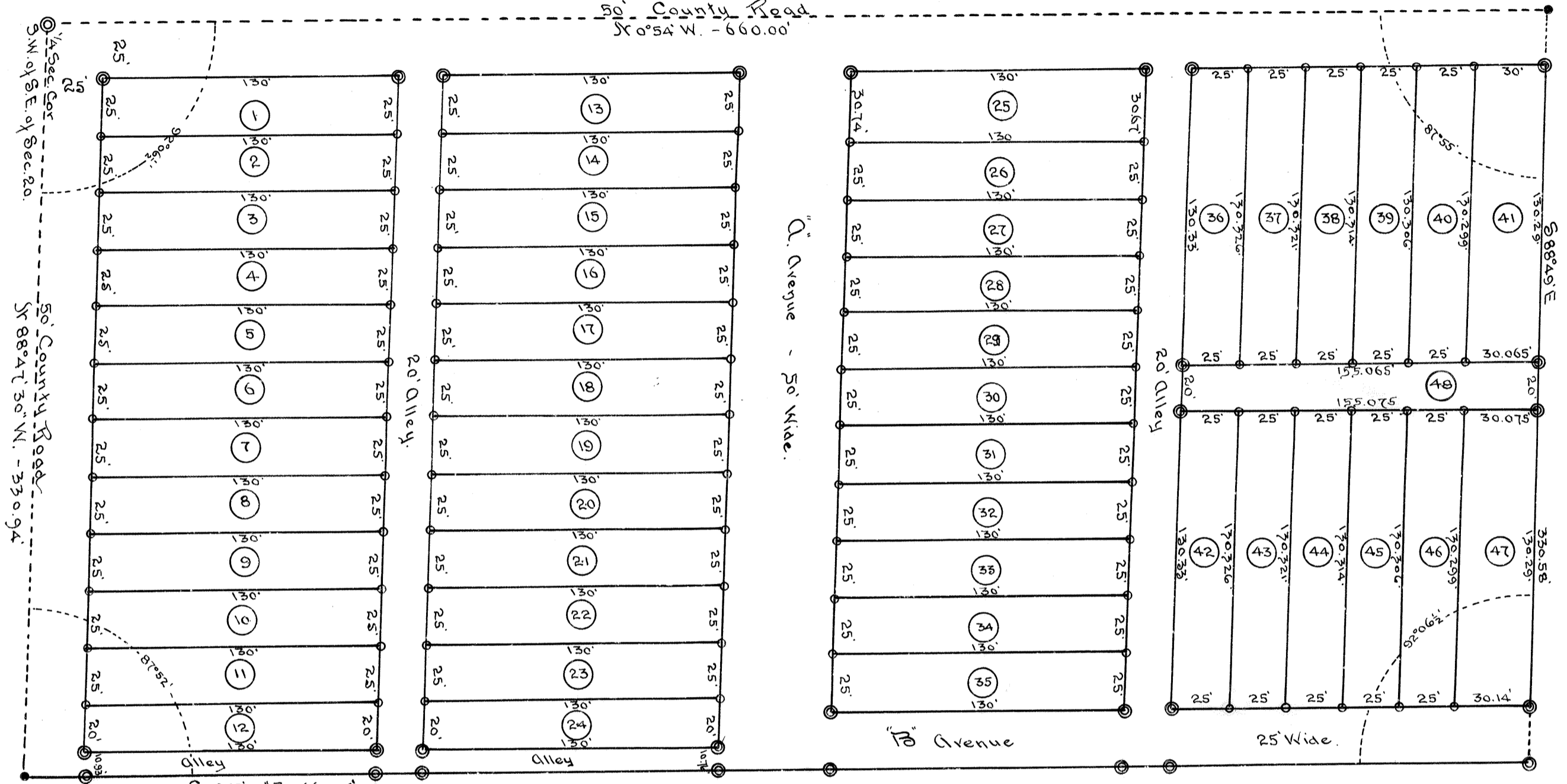


MAP OF THE TIDEWATER TRACT.
