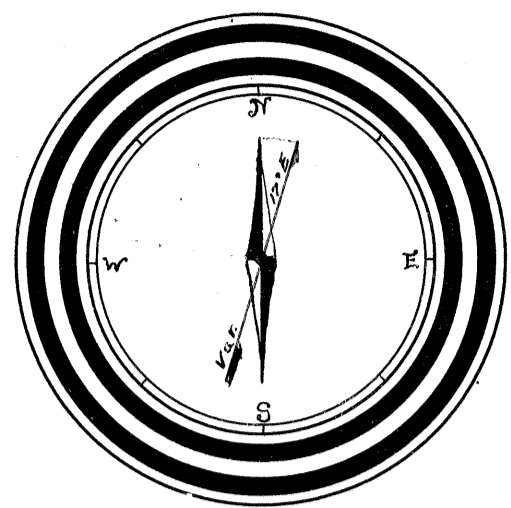


MAP of The WEIL COLONY

SEC. 20 T. 35 S. R. 9 E. M.D.B.M.

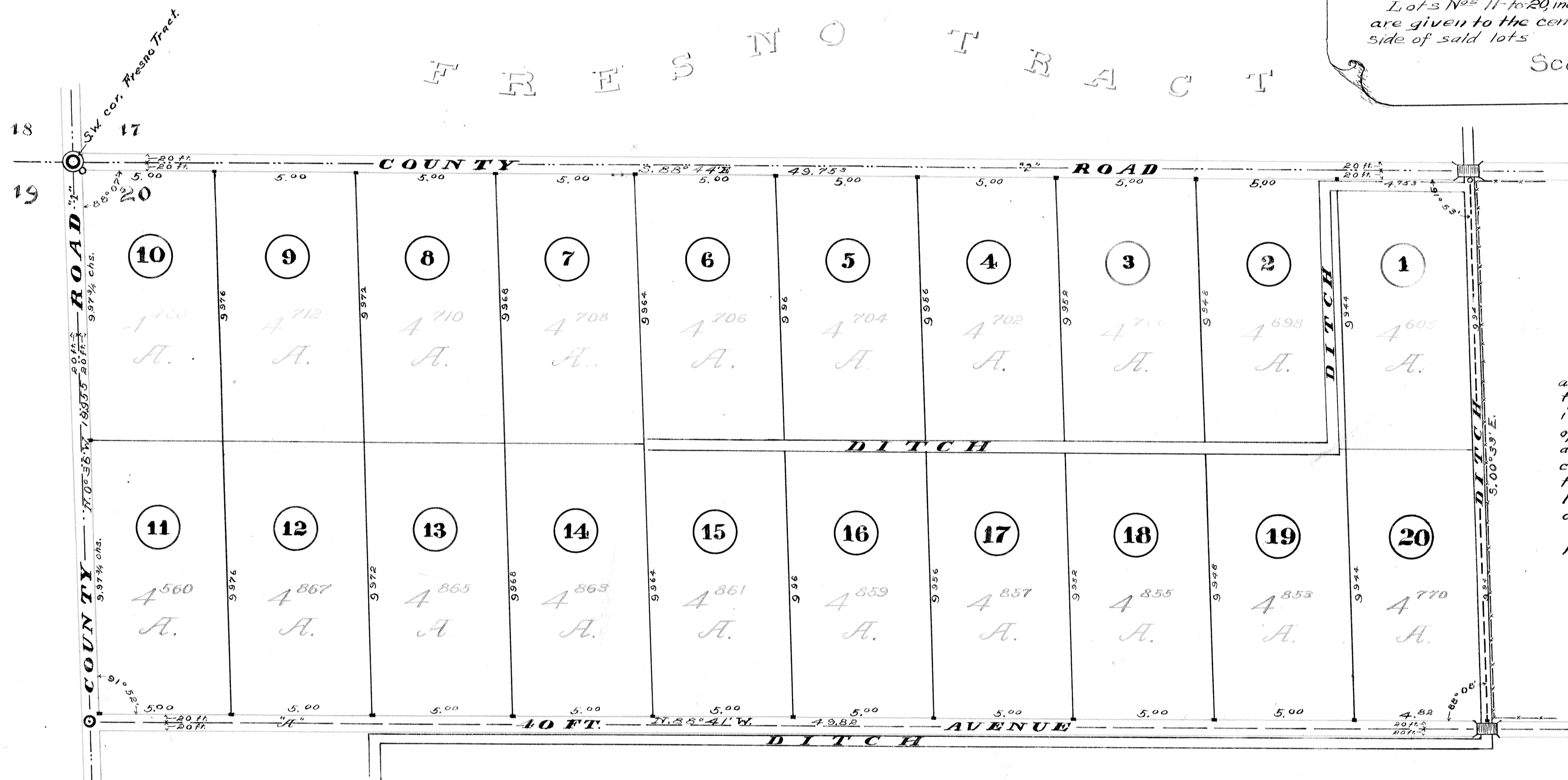


Reference Tablet

All measurements are given in chain except when otherwise marked
 Lots Nos 1-20 measurements and areas are given to the center of the ditch on the East side of said lots
 Lots Nos 10-11 measurements are given to the center of the County Road on the West side of said lots, but areas are calculated to the East side of said County Road
 Lots Nos 1-10 inclusive, the areas are calculated to the South line of the County Road on the North side of said lots but measurements are given to the center line of said County Road
 Lots Nos 11-20 inclusive, the measurements and areas are given to the center line of the 40ft. Avenue on the South side of said lots
